



6 Month Membership Automatic Recurring Billing Agreement

Description of Membership

This is an annual Unlimited Drop-In Membership allowing you unlimited access to any Drop-In class for which you have been qualified at Fitness with a Twist. See qualifying classes on members page.

Length of Term: Membership shall commence on the starting date and last for 6 months at guaranteed rate of \$125.00 a month.

A Yearly Registration Fee of \$25.00 is required.

Frequency of Payments

Payments will be automatically charged to the credit card or bank account you provide below monthly on the day you started the Agreement.

Months are billed current.

No prior notice will be given but you will get an email informing you when the charge was made (providing email is on file).

Automatic Recurring Payment Failure.

If your automatic recurring payment is declined, you will be contacted by phone or email. We may permanently restrict your ability to use a certain payment method if that payment method fails multiple times. REMEMBER: If your Automatic Recurring Payment fails, you will need to provide another payment method. In the event any payment is not made and you do not make a payment by the end of your billing cycle, your privileges to use Fitness with a Twist will be changed to a pay as you go basis. If you fail to remedy the payment method you may be penalized for premature termination of this Agreement.

Cancellation of Automatic Recurring Payment.

You have the right to withdraw your consent to this Automatic Recurring Payment after 6 months time.

Upon termination you will **Not** be entitled to the \$125.00 monthly offer.

A price increase will applied to \$125.00 monthly, if you choose to re-apply.

However if you terminate prior to the 6 month initial term, you will be charged the full monthly unlimited rate of \$145/month for the months you used our facility. (A Penalty Fee of \$150.00 will be collected)

Changing Automatic Recurring Payment.

If you would like to change your Automatic Recurring Payment including, for example, making a change from one credit or debit card that was initially selected to another credit or debit card or bank account, you must authorize the recurring payment with the new credit or debit card or bank account by calling Fitness with a Twist.

Your new information will be implemented before the next billing cycle for your membership.

This is Agreement is not transferable.

AGREEING TO THESE CONDITIONS

By providing my credit, or debit card or bank account information ("Payment Method"), I AGREE that I have read and understand this Automatic Recurring Payment Agreement In addition, I authorize Fitness with a Twist to charge \$125.00 once every month for 6 months to the specified Payment Method; and I authorize the financial institution for the Payment Method, specified above to charge my account and remit payment for membership to Fitness with a Twist. This authority will remain in effect until I give notification, as required under this Agreement, to terminate this authorization.
